

# 2019-2020 TENNESSEE FCCLA DRESS CODE

Since 2017-18, National FCCLA has required the below official dress requirements for all National FCCLA events. Please make sure to review the **National FCCLA Dress Code** as the Tennessee FCCLA Dress Code will be covered differently as outline below. **Again, the below dress code is for Tennessee FCCLA events ONLY. The National FCCLA Dress Code should be followed for all National FCCLA Events.**

FCCLA Leadership Conferences provide excellent opportunities for members to convey to others the positive and professional image of FCCLA. Members' behavior throughout the Tennessee Leadership Conferences is the only image others in the facility and host city may ever have of our organization. **Advisors are responsible for enforcing the dress policy with their students. Delegates and guests not adhering to the dress policy will not be admitted into sessions.**

***FCCLA branded shirts and the FCCLA official blazer are always appropriate and strongly encouraged.***

## **APPROPRIATE ATTIRE FOR SESSIONS** *(Including Fall Leadership Conference, ALL State Leadership Conference Sessions)*

### **FEMALES**

- The official FCCLA blazer is always acceptable attire
- Red, black, or white polo or oxford shirt (long or short sleeves)
- Black dress slacks or khaki pants (no capris)
- Black or khaki skirts (must come to the knee)
- Dress shoes or sandals
- Jeans, t-shirts and athletic wear are NOT permissible

### **MALES**

- The official FCCLA blazer is always acceptable attire
- Red, black, or white polo or oxford shirt (long or short sleeves)
- Black dress slacks or khaki pants (no shorts)
- Dress shoes
- Jeans, t-shirts, and athletic wear are NOT permissible

### **ADVISORS | CHAPERONES | GUESTS**

- Business casual
- Jeans, t-shirts, and athletic wear are NOT permissible

## **STAR EVENTS PARTICIPANTS/SKILLED DEMONSTRATION PARTICIPANTS** *(District and State STAR Events)*

- Follow event specifications for dress and wear appropriate clothing for the nature of the presentation

### **DRESS CODE FOR FCCLA SOCIAL ACTIVITY NIGHT**

*(State Leadership Conference Only)*

- Black or Khaki pants, jeans with no frays or holes
- FCCLA SLC t-shirt (unaltered)

### **DRESS CODE FOR BANQUET/GALA**

*(State Leadership Conference Only)*

- Formal/Semi-formal dress
- No skin-tight or revealing clothing
- No short skirts/dresses (must come to the knee)

### **UNACCEPTABLE ATTIRE AT ALL FCCLA SESSIONS**

- Skin-tight or revealing clothing
- Midriff-baring clothing
- Extremely short skirts
- Clothing with printing that is suggestive, obscene, or promotes illegal substances
- Athletic clothing
- Swimwear
- Rubber, beach type flip flops
- Night wear (pajamas) should not be worn outside of your hotel room
